## Country Markets

Imaging, Dental Products, Orthopaedics & Prosthetics, Patient Aids, Other Medical Devices), data and analysis of top-line and public and private healthcare spending and analysis on healthcare insurance, infrastructure and personnel, industry regulations (cybersecurity concerns, intellectual property, market access and pricing and reimbursement), medical devices trade balance and imports/exports, government policy, R&D pipeline, approvals and product launches, industry developments, competitive landscape and company profiles.

## Data and Forecasts

Comparable indicators for the medical devices sector in each country market and across six dedicated product segments, with annual and monthly trade balance, import and export trade data and sales and forecasts for:

- **Consumables** – including dressings, suturing materials, syringes, needles, catheters, blood-grouping reagents, first-aid boxes and kits, ostomy products and surgical gloves.
- **Diagnostic Imaging** – including electrodiagnostic apparatus (electrocardiographs, ultrasound, MRI, scintigraphic), radiation apparatus (CT scanners, X-ray, A, B, C ray), and imaging parts and accessories (contrast media, medical x-ray film, x-ray tubes).
- **Dental Products** – including capital equipment (drills, chairs, x-ray) and instruments and supplies (cements, instruments, teeth and other fittings).
- **Orthopaedics & Prosthetics** – including fixation devices, artificial joints and other artificial body parts.
- **Patient Aids** – including portable aids (hearing aids, pacemakers and other) and therapeutic appliances (mechano-therapy apparatus, therapeutic respiration apparatus).
- **Other Medical Devices** – including wheelchairs, ophthalmic instruments, hospital furniture, medical and surgical sterilisers, ultra-violet or infra-red ray apparatus and other instruments and appliances.


